- Manage assigned regulatory inquiries and activities (EEOC, OFCCP, Wage and Hour) such as investigations and the completion and submission of required documentation including EEOC position statements
- Assist with management with conducting investigations and provide sound advice regarding disciplinary action as needed. Advise compliance regarding the outcome and resolution as appropriate and engage outside counsel as deemed necessary



- Provide training and support around new HR policies and procedures or programs
- Analyze HR metrics and demands of HR support to identify trends and make recommendations for training and development to achieve the best outcome. Partner with Training and Development to deliver and facilitate learning for field-based leadership
- Demonstrate the application of best practices relative to business needs and recommend policy or process updates where needed
- Provide regular communication and reporting to leadership around the consumption of HR support, training and development needs, retention and application of trainings delivered etc
